# Thanks to you, children from troubled homes have a safe place to play.

A grant for \$9,581 was awarded to St. Jude House. St. Jude House is a 40-bed shelter for victims of domestic abuse. It is the largest shelter of its kind in the area. St. Jude House provides housing and services to approximately 500 adults and children each year at no cost.

Over half of those served at St. Jude House are children. While St. Jude House provides services through advocacy and group support to help children recover and heal from the trauma of domestic violence, children also need play and physical activities. To this end, St. Jude House created a playground for the children at the shelter using funds provided by the Crown Point Community Foundation, the Dawn Bracheau Foundation and the Service League.

"This is a game changer for us because we serve more children than adults," said Ryan Elinkowski, Executive Director of St. Jude

House. "To have something like this, which will last for so many years to come, will truly bring joy to the children that we serve. It's a really exciting time for us."

#### Animal Related - \$1,000.00



Bobbie Gintert's love of learning became a love of giving. She was born in Gary in the Great Depression, a truly humble beginning. "My dad worked in the steel mill," Bobbie said. "We didn't have anything but I didn't know any different because nobody had anything. You don't miss what you never had."

She discovered she had an aptitude for learning at a young age.

"Learning was easy for me," Bobbie said. " I loved to learn." She combined this love for learning with a strong work ethic.

"Because I had good grades, my last year in school I went to school for half a day and then worked for half a day," Bobbie said. "Because if I wanted any clothes, that's how you got them."

Bobbie went to work at Kroger's, where she met her future husband Glenn W. Gintert. She and Glenn married in 1947 and raised three children together.

"When we left Kroger's in 1960, we were looking for something to do," Bobbie said. "So what little bit of money we had, we put together and bought into this store that needed help." That store was Wilco Foods. "The family all worked," she said. "In the mid 1970's we opened our flagship Wilco store in Lowell. It grew to four stores."


Bobbie applied her love of learning to the grocery stores.

"I learned how to be a bookkeeper and how to run the front end of a store," she said. "In turn, after learning things, I enjoy teaching it to somebody else. That was my favorite part of owning a business and I liked working on the floor with people."

She also helped oversee a major innovation at her family's grocery stores.

"We learned a computer system, and then I taught it to others," Bobbie said. "We were the first store in Indiana to have computerized scanning."

After several failed attempts at retirement, Bobbie settled down to a



life of relative leisure. She now lives at Wittenberg Village in Crown Point. She is a talented painter and wood carver. Philanthropy has also become an important part of her life. Bobbie uses her retirement account to make charitable contributions to the Crown Point Community Foundation becasue it makes her gifts more impactful.

"Everybody has a favorite charity," she said. "Mine would be the Crown Point Community Foundation. It just does so many good things in so many ways, and their support stays local. I'm happy to be part of that."

Bobbie enjoys the tax savings that comes from making contributions to the Foundation from her IRA.

"It's a savings for me because I don't pay tax on it," Bobbie said. "It's before tax dollars that you put it in. And if you take it out and give it directly to a nonprofit then it's a tax saving, which makes sense. Sometimes I'm lucky enough to qualify for a great match, which is even better," Bobbie said.

Still young at heart and an avid learner, Bobbie has no plans of slowing down soon. She points to one of her favorite mugs.

#### MAKING QUALIFIED CHARITABLE DISTRIBUTIONS FROM YOUR IRA

If you are age 70 ½ or older, you may be thinking about your Required Minimum Distribution (RMD) from your IRA. Please consider directing your distribution to the Foundation, minimizing your taxable income while making a big impact in our community. CPCF is a qualified 501(c)(3) organization and can accept Qualified Charitable Distributions (QCD) directly from your financial institution. These distributions directly reduce taxable income regardless of whether you qualify to itemize. Here are the eligibility requirements:

- Donors must be age 70 ½ or older.
- Distributions up to \$100,000 can be made by an individual or \$200,000 for a married couple.
- Distributions must be paid directly to the organization from the IRA custodian.
- Distributions cannot be directed to a Donor Advised Fund.
- No goods or services can be received in exchange for the distribution.

# This year's annual Women's Giving Circle event continued its tradition of community and charity.

The Women's Giving Circle is a collective giving effort of the Crown Point Community Foundation. The WGC invites all women from the area to gain membership with a \$100 or larger annual donation which can be made throughout the year.

On the second Tuesday in September of each year, members gather to grant money to local charities.

**This year, the ladies donated an astonishing \$19,000!** They granted \$9,000 at the event. \$2,000 to each charity receiving the most votes. In addition to the four, \$2,000 grants awarded, the WGC members also granted a \$1,000 Scholarship for an Adult Learner (21 and over).

Another \$9,500 was placed in the CPCF Community Endowment Fund. This fund provides grants to support community needs and programs three times each year through the grant process at the Foundation.

"As the Buddy Bag Program continues to grow and serve more Crown Point low income students, a grant like this is instrumental in keeping the program vibrant," said Bonnie J. Meyer, Director of Outreach and Missions at Crown Point First United Methodist Church. "We are grateful for this grant and for the opportunity we have to make a difference in the lives of students in need."

# Five Questions for George Letz

## What are you most proud of?

I am most proud of my children and how successful they have become in their own fields of work.

Also, securing a successful referendum in my school district (MSD of Boone Twp) after it had suffered a failed attempt during the previous eleven months. The coordination of all phases of completing the desired result (publicity, town-hall meetings, phone calls, knocking on doors, etc.) is a monumental task for everyone in the school corporation.

## What is a book you've enjoyed recently?

The Vanishing American Adult by Senator Ben Sasse of Nebraska. Senator Sasse diagnoses the reasons that this generation is having difficulty growing up and offers a path for raising children to become active and engaged citizens. He identifies four core formative life experiences: hard physical work to appreciate the benefits of labor; travel to understand the people of the U.S. and the world; building a personal library to encourage exposure to new ideas; nurturing physical health/building stamina to develop discipline. I have also read books recently on "The Age of Eisenhower' and "Thomas Jefferson -The Art of Power."

#### What attracted you to serve on the Crown Point Foundation Board of Directors?

I had served for several years on the Foundation's ad-hoc committee which determines the recipients for CPCF scholarships. Having the opportunity to interview students from the area seeking these grants is a real honor for me and the other individuals serving on this committee.

A school principal has the opportunity to not only influence the education of thousands of children but also develop relationships with their families. I still meet students who are now adults on the street and I learn what they have done with their lives. It is a great feeling!

Stay busy and find activities which you enjoy. Serving on various youth oriented boards (CPCF and Campagna Academy) allows me to serve my community in a unique manner. Also, spending time with my seven grandchildren allows me to watch an entire new generation grow and mature. Participating in their activities brings happiness to both Sharon and me. We are vary blessed to have this time with them.

George Letz was born and raised in Crown Point. His family was instrumental in developing the Letz Manufacturing Company, a long time employer in the city. But George choose to pursue education. After attending Valparaiso University, he earned advanced degrees at Indiana University and Purdue University.
